



Twin Rivers: Game Day Giveaways

Overview:

Starting October 6th, 2024, and ending on Sunday, January 5th, 2025, during regular season Monday night football games or during any Seattle Seahawk televised game (during Twin Rivers Bar hours of operation), participants can receive an entry for a Tyler Lockett autographed Seattle Seahawks Jersey and up to \$500 in cash, with the purchase of two (2) individual alcoholic drinks.

How to Gain Entry:

1. Participants must be at least 21 years of age to participate.
2. Participants must purchase two (2) individual alcoholic beverages at Muckleshoot Bingo's Twin Rivers Bar during Monday night regular season games or during any Seattle Seahawk televised game during regular hours of operation.
3. Each time a participant meets the above requirements, they will be issued an entry for the grand prize drawings.
4. To gain one free entry, participants must meet the requirements of rule #1 above and visit the Players Club on 10/16/24, 11/20/24, 12/18/24, 1/22/25, or 2/5/24 from 1 pm – 3 pm.
5. Participants can place their completed entry ticket(s) in the drawing drum at Twin Rivers bar immediately after receiving them or retain their entry ticket(s) until the drawing date, Super Bowl Sunday, February 9th, 2025, by 3 pm.
6. Lost or damaged entry tickets will not be replaced. No duplicate or copied entry tickets will be accepted.
7. Participants may earn unlimited entries, but they can only receive up to two (2) entry tickets per day (total of four (4) drinks).
8. Drawing winners will receive the prizes as listed in the Pay Table section of these rules.

Exclusions: Muckleshoot Bingo Employees are NOT eligible to participate in this promotion or win a prize drawing and must not enter. If an employee should be drawn as a prize winner, their entry will be voided and another winning entry will be selected.

How to Play/Win:

1. Starting on October 6th and ending on Sunday, February 9th, 2025, at 3 pm, participants must have deposited their completed entry tickets into the ticket drawing bin located at Twin Rivers Bar.
 - a. Participants must clearly print their first and last name and phone number on every ticket they enter into the ticket drawing bin. If the name is unreadable or the required fields are left uncompleted, MIB will draw another winning ticket.
2. On Sunday, February 9th, after the completion of each Super Bowl quarter, Muckleshoot Bingo will randomly draw 1 (one) entry from the ticket drawing bin to win the corresponding prize as listed in the Pay Table section of these rules. If the game goes into overtime, no additional drawings will be done.
3. The winning participant's name will be verified by another present MIB employee. Once the name has been verified, it will be announced over the in-house PA system.
4. The winning participant must be present to win and must claim their prize at Twin Rivers within 5 minutes of their name being called. If the winning participant does not report to Twin Rivers within 5 minutes, another winning participant will be drawn.
5. Participants must have a valid ID and social security number to claim their prize.
6. Once the winning participant has been verified, the participant's winning entry ticket will be removed from the ticket drawing bin.
7. Participants can win multiple times and have unlimited entries.

General Rules:

1. The Muckleshoot Indian Tribe, any other contest sponsor, and their affiliated entities and their respective officers and employees shall be released and discharged from any and all claims, losses, injuries, demands, or actions which arise out of or are in any way related to the prize(s), the receipt, use or enjoyment of prize(s), or damages or losses related to the contest.
2. The Tribe reserves the right to postpone, suspend, or terminate the promotion or amend the rules at any time without notice to participants.
3. By entering or participating in the promotion, participants grant Muckleshoot Indian Tribe and its affiliated entities the right to use their names, likeness, or voice for promotional purposes without further compensation or permission.
4. Prizes may not be traded or transferred. Substitution of cash, or equivalent for noncash prizes unless expressly stated in the contest rules is not permitted, provided that, in the event that the Tribe at its sole discretion reserves the right to substitute cash in the event that a noncash prize becomes unavailable. In accepting a prize, the winner accepts the prize "as is" with no warranties.
5. Winners of promotional contests will be required to present valid photo identification acceptable to the Tribe, social security number, and complete an IRS Form W-9 and a winner release form before a promotional contest prize will be awarded. Failure to provide required identification and complete required IRS Form W-9 and a winner release may result in forfeiture of promotional contest prizes.

6. Participants acknowledge that Prizes may be subject to tax withholding under applicable federal regulations and that payouts may be reduced due to withholding requirements. The Tribe will report winnings in excess of \$600 in cash or fair market value during a calendar year to the IRS and such winners will receive an IRS Form 1099.
7. For promotional contests that require physical participation, selected participants who are physically unable to participate may designate a person other than an employee of Muckleshoot Casino or Bingo to participate on their behalf.
8. Participants are responsible for hearing contest announcements and the Tribe shall not be responsible in any manner for the failure of a participant to hear or respond to contest announcements. In promotional contests involving a drawing, in case of public address system failure the drawing may continue and in such event the selected participant's name will be announced without amplification at the drawing location.
9. The Tribe is not responsible for lost or stolen entries, or coupons, computer malfunctions or other incidents resulting in loss of entries.
10. The Tribe is not responsible for inability to enter a drawing due to long lines or other causes.

Muckleshoot Bingo (MIB) Employees who are eligible to play bingo or VGD machines as outlined in the personnel policies are eligible to play during the promotional timeframe; however, MIB Employees are NOT eligible to participate and win in VGD tournaments, drawings of any kind, giveaways, Hot Seat promotions, Free Play promotions, and select discount and coupon offers.
